### 7.0 REPORT OF THE MEDICAL OFFICER OF HEALTH

The <u>Report of the Medical Officer of Health</u> dated September 23, 2020, was presented to the Board of Health for information purposes.

An additional verbal update from the Medical Officer of Health was also provided, as well as questions by Board members addressed. The discussion was as follows:

- The need to address the systemic problems in the system related to COVID-19 and health equity; it's a call to action to take a critical look at those most vulnerable
- There has been a significant increase in cases globally, nationally, and provincially
- Locally, there has been a slight increase; the district is now up to 40 cases with one death
- Provincially, the trend over the summer months was 80-120 new cases per day; that is now up to 400 new cases per day, with it trending upward
- The percentage of positivity is increasing as well
- In order to address this, the province has revised the limits for indoor and outdoor gatherings
- The health care system is currently not overwhelmed with the increase in cases
- More data is needed before it can be determined if this is a resurgence due to increased travel and/or social interaction, or if this is the start of a second wave
- Regardless, it is concerning and it coincides with schools re-opening
- The province is already seeing outbreaks in schools in geographic areas with higher case counts
- The Health Unit has been working very closely with school boards in our district for months now preparing for school re-openings to be as safe as possible
- Collaboration between public health, Ontario Health, community partners, school boards, the government, and the public is ongoing in an effort to protect the public
- People need to do their part and adhere to public health recommendations by respecting gathering limits, staying within their social circle, use face coverings, physically distance, and be vigilant with simply hygiene methods
- Individually, these measures have an effect, but a comprehensive approach will make the difference
- There is still no indication of a vaccine in the near future
- The most important thing at this point is to flatten the curve, as was done in the first wave
- Collectively, we can get ahead of this by supporting the provincial initiative for stringent gathering limits
- There are concerns for the potential of a twin pandemic with influenza season approaching
- It is more important than ever to get the flu shot

- The Health Unit is already seeing more interest and more demand this year
- It is anticipated that the first shipments of influenza vaccine will be received by the end of this month or early October
- The initial focus will be high risk groups
- The Health Unit is working with pharmacies on a coordinated response
- In following the statistics of the southern hemisphere, which is always ahead of us, they did see a reduction in the number of flu cases with this year's vaccine
- Work is already underway to prepare for various options for influenza clinics across our district

Q: Do we have any sense of the uptake of the COVID-19 app?

A: While we do not have a lot of information on the national app, it does require a significant amount of the population engaged for it to work really well. All initiative in place to stop the spread of COVID-19 is helpful.

Q: Are the vast majority of schools supporting the use of face coverings?

A: Yes, compliance has been great. Students and teachers alike have adjusted to the recommendations. Masks alone is not the answer, a comprehensive approach that is needed. Every little bit helps. The situation is fluid, and we will have to be flexible with the measures required to slow the spread. The public really needs to be congratulated for all of their efforts.

Q: What about upcoming activities like Halloween and public Christmas events? Municipalities are being approached regarding cancellation of events.

A: Things are changing rapidly; we will have to make changes according to what the numbers are showing. As it is, the numbers are going in the wrong direction. Unless this is brought under control very quickly, the Health Unit does not think it is in the best interest of the public to have kids out door-to-door, or in any type of social gathering outside of their immediate social circles. It may look different this year, but there are creative ways to celebrate safely within people's own social circles.

The Centers for Disease Control and Prevention (CDC) has made their recommendation that Halloween is a high-risk situation.

Both the province and the Health Unit will be coming out with statements and recommendations related to upcoming events and holiday celebrations. Municipalities will need to refer to public health guidelines and recommendations.

Q: Safe consumption site; the province is looking for feedback from the City. What is the Health Unit's opinion?

A: The Health Unit has been in favour of safe consumption sites for quite some time. Substance misuse is a pandemic in itself. The Health Unit feels that the only way to approach it is from a harm reduction point of view, and would advocate for more safe consumption and treatment sites in Ontario.

The difference between safe consumption site and safe supply was addressed.

Q: British Columbia has changed their daily checklist for children going to school to seven symptoms, is there any consideration for the province following suit?

A: Based on clinical data on how it presents in children, yes, the province is considering changing their checklist. The province recognized it as an issue and is currently in consultations with Public Health Ontario to make it more manageable.

Q: Substance misuse in the community, namely sharps?

A: The Health Unit is working with municipal councils for placement of sharps bins. We currently have a sharps bin in West Nipissing. The Health Unit has limited budget and capacity, but will work with municipalities by supplying the bin; however, municipalities would be responsible for disposal of the sharps.
