## 7.1 Reconciled Budget 2022

The following motion was read:

## Finance and Property Recommendation #FP/2022/06/04 \*Jacko/Stickland

**Whereas,** the North Bay Parry Sound District Health Unit received funding for 2022 from the Ministry of Health (Ministry); and

**Whereas,** the Board of Health must approve all funding from the Ministry in order to receive the transfer payments; and

Whereas, amendments to the previously approved funding affect the Total Shareable Base; and

Whereas, the following three options were provided for consideration:

- 1. That the excess 2022 municipal levy be reduced by \$79,836, prorated by population,
- 2. That the excess 2022 municipal levy be deposited to the Municipal Reserve, or
- 3. That the excess 2022 municipal levy be used to fund 2022 costs at 100% for the Adult Dental program to reduce the wait list.

**Therefore Be It Resolved,** that the Finance and Property Committee recommends that the Board of Health for the North Bay Parry Sound District Health Unit approve the reconciled 2022 Board of Health budget with Net Expenses for \$26,018,017; and

**Furthermore Be It Resolved,** that the Finance and Property Committee recommends that the Board of Health proceed with option 3.

#### Discussion:

The Finance and Property Committee was advised that Ministry of Health 2022 budget approval was significantly less than the Board of Health approved budget proposal initially submitted. The details and recommendations outlined in the attached briefing note were discussed.

Finance and Property Committee members suggested a) that the Medical Officer of Health connect with the appropriate contact at the Ministry of Health for direction on the best approach for the Board of Health to advocate for appropriate funding for the Health Unit, and b) municipal representatives of the Board of Health apply for a delegation to meet with the Minister of Health at the Association of Municipalities of Ontario (AMO) Annual General Meeting and Conference scheduled for August 14 – 17, 2022, in Ottawa.

Dr. Chirico agreed to connect with his contact at the Ministry.

A Board member from the City of North Bay agreed to take on the task of applying for a delegation, with support and background information provided by the Health Unit.
