POSITION SUMMARY:

Working as a member of the Environmental Health team, the incumbent is responsible for carrying out inspections and investigations under the provision of the [Health Protection and Promotion Act](#) (HPPA), [Ontario Public Health Standards](#) (OPHS), and relevant acts and regulations, reporting on public health related programs such as food safety, drinking water, general and institutional sanitation, collecting and submitting samples for laboratory analysis and interpreting the results. All work is consistent with the mission, vision, values, strategic priorities, policies, and standards of the Board of Health.
